Opening Times and Hours

We are open 51 weeks per year, closing for the last week of December and all Bank Holidays. Our Core Hours are Monday to Friday 08:00-18:00, with additional Operating Hours 07:30-18.30 for an extra charge of £10 per 30 min. This must be pre-booked monthly in advance.

T & C's

- 1. A £500 deposit will be required to secure a place. This will be offset against the final invoice. If you decide not to enroll, your deposit will be refunded in full, given you provided two calendar months' notice
- 2. Minimum attendance may be applied depending on the nursery's availability.
- 3. Ad-hoc sessions are subject to availability and must be pre-booked, with 24 hours written cancellation notice.
- 4. We offer a 5% sibling discount for the eldest child only and a 10% NHS discount. Only one discount can be applied.
- 5. Monthly fees are payable in advance by Direct Debit, tax-free childcare, and some voucher schemes on the 1st day of each month. Fees may be reviewed in line with our terms and conditions.
- 6. Fees are prorated across the year and are inclusive of 2 inset days, bank holidays, and nursery closures.
- 7. The fees due after funding are applicable the term after your child turns 9 months old or 3 years old.
- 8. We require two months' notice for any booking pattern changes or contract termination.
- 9. Late collection charges: £15 for the first 10 minutes and an extra £15 pounds every ten minutes thereafter.

How funding works

9 months to 3 years funding

Funded 15 hours a week for 38 weeks is available to eligible working parents the term after their child turns 9 months. Since we are open 51 weeks a year, the funding is stretched and this equates up to 11.2 free hours a week.

Funded 30 hours a week (coming September 2025) for 38 weeks is available to eligible working parents the term after their child turns 9 months. Since we are open 51 weeks a year, the funding is stretched, and this equates to 22.4 free hours a week.

Funded hours are limited to 3 hours per half day and 6 hours per full day. The total owed is equivalent to the unfunded hours only - funded hours are entirely free.

Over 3 years funding (incidental charge of £2.30 per funded hour only)

The Universal 15 hours, 38 weeks funding is currently available to everyone the term after their child turns 3. Since we are open 51 weeks a year, the funding is stretched and this equates up to 11.2 free hours a week.

The Extended 30 hours, 38-week funding is available for eligible working parents from the first term of enrolment. Since we are open 51 weeks a year, the funding is stretched and this equates to 22.4 free hours a week.

Funded hours are limited to 3 hours per half day and 6 hours per full day. The total owed is equivalent to the unfunded hours only - funded hours are entirely free - and an incidental charge of £2.30 per funded hour only. This is to contribute towards the cost of various incidentals that the funding doesn't cover, and, most notably, extended curriculum and other extracurricular activities for older children.
